- 1- All submitted photographs must be taken in Cold Lake, Alberta.
- 2- Photo entries must be taken by the individual submitting them.
- 3- Individuals may submit up to two (2) photographs per category.
- 4- Photographs must be submitted to a specific category.
Photographs not submitted to a specific category will be disqualified.
- 5- Individuals may submit entries to more than one (1) category.
- 6- No captions.
- 7- Photo editing is permitted.
The editing should be used in moderation to clarify images and remove minor imperfections. Excessively edited images may be disqualified.
- 8- All photographs must be submitted in JPEG format.
- 9- All photographs must be submitted on a CD with no less that 300 DPI per entry and no smaller than 4x6 photographs.

Photograph Permission/Release Form:
